Firearms, sharp objects and explosives

Prescribed medication and liquids, syringes and needles for patients requiring them onboard the aircraft, in which case, they must show their medical prescription and/or certificate

Authorized oxygen concentrators with a medical prescription

Disposable razors

Handguns, revolvers, rifles, shotguns, firearms and ammunition, cartridges, and compressed air

Flare guns, sporting goods and/or martial arts items

Ice axes, ice picks, corkscrews and cattle prods

Toy guns or realistic replicas of firearms

Bows, crossbows, and arrows

Axes, knives, pocket knives, letter openers, swords, scissors, box cutters, scalpels, needles, and items with pointed tips and blades

Nail clippers and razor blades

Drills, saws, hammers,

screwdrivers, and other power tools

- Flares, explosives, grenades, detonators, and military items
- Canisters and other smoke producing devices (smoke bombs)
- Fireworks and all other types of gunpowder or explosive materials

Restricted items

Stun guns

Cutting and welding gas torches and devices

Dry cell batteries for motorized wheelchairs

Large, hand-held sporting equipment (golf clubs, hockey sticks, pool sticks, baseball and softball bats, and other similar objects)

High-intensity discharge lamps

Mercury barometers and industrial thermometers

Wet cell batteries for motorized wheelchairs

Artículos restringidos

Medical oxygen cylinders weighing less than 11 lbs. (5 kg.) and less than 40 PSI, with a medical prescription, and only as checked baggage






Liquids, gels, aerosols, and nail polish remover must be held in 3 oz. (100 ml.) containers and packed in one clear transparent, resealable 1 quart (1 liter) size plastic bag







Customers may carry up to five quarts of brand name wine and liquor with alcohol content between 24% and 70% in unopened retail packages in carry-on on domestic and international flights, purchased in Duty Free stores after clearing the security checkpoint. Greater amounts of alcohol must be packed in checked baggage.

Small, rechargeable and non-rechargeable lithium batteries for cameras, mobile phones, iPods, laptops, MP3 players, watches, video and audiovisual equipment, and medical equipment can only




be carried onboard.

-  Up to five quarts of vinyl paint per person as checked baggage only
-  Up to 5.5 lbs. (2.5 kg.) of dry ice per person, in a package that allows venting of carbon dioxide gas
-  Enamel paint
-  Acid and corrosive substances including mercury and chlorine solvents
-  Wet batteries and fire extinguishers

-  Butane and propane gas, gasoline, and other potentially flammable liquids or materials
-  CO2 cartridges
-  Infectious or biohazardous materials (infected blood, bacteria, or viruses)
-  Insecticides and lighter fluids
-  Radioactive materials
-  Lithium / Lithium-Ion Rechargeable and non-rechargeable medium and large size batteries, greater than

160 Wh or any other amount exceeding standard travel requirements (These batteries are not allowed as cargo).

-  Hoverboards (Self-Servicing devices powered by lithium batteries).
